ADDENDUM OF PROBABLE CAUSE


DEFENDANT: RAKEEM CHAVEZ FLORENCE

On 070909 Escambia County deputies responded to the scene of a Home Invasion double Homicide. Upon arrival the bodies of Byrd and Melanie Billings were located in the bedroom obviously dead from multiple gunshot wounds. Two of the doors leading into the residence appeared to have been forced open and review of the video surveillance from the residence revealed three intruders entering the residence after all exited in a red in color Dodge van. All three suspects were armed and wearing masks, two carrying long guns, one possibly being a pump shotgun and a third carrying a handgun. Spent shell casings recovered at the scene were 9mm shell casings. The video showed the invasion taking approximately 4 minutes from start to finish. Eight children all with varying degrees of disability were also located in the residence at the time of the incident, although none of the children were found to be injured.

On 071309 interviews were conducted at the Okaloosa County Sheriff's Office by Investigators of the Okaloosa and Escambia County Sheriff's Office. During these interviews Frederick Lee Thornton and Rakeem Chavez Florence after being advised of their rights gave statements to investigators. In these interviews both Florence and Thornton admitted to being involved in the Home Invasion. They stated that forcibly entered the residence and while in the commission of the Home Invasion Both Byrd and Melanie Billings were shot to death.

Florence stated that he was armed with a [REDACTED] during the commission of this crime.

Based on the statements of the defendants and the information which was received from Escambia County Investigators, This Investigator has reason to believe and does believe that Freddie Lee Thornton and Rakeem Chavez Florence did commit the crimes of an open count of Murder (2cts). These offenses did occur in Escambia County Florida and this arrest is pursuant to the assistance to Escambia County Sheriff's office.
