[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 07/09/2009, in Escambia County, Florida Leonard Patrick Gonzalez Jr did knowingly and unlawfully commit the offenses of Homicide in violation of FSS. 782.04, and did also commit the offense of Home Invasion Robbery

with a Firearm in violation of FSS. 812.135(2a), to wit:

In a recorded statement on 7/12/2009, Leonard Gonzalez Sr. reported being the get away driver in a Home Invasion on 7/09/2009. Gonzalez reported that he along with his son Leonard Gonzalez Jr., his son's friend Wayne Coldiron and several black males whom he couldn't name had gone to the residence located at 9717 Mobile Highway and that he had ridden to the scene in the red Dodge van of his son's and had stayed in the van moving to the driver's sit as the rest of the suspects entered the residence and committed the robbery. Gonzalez advised he moved the van forward after the others went into the residence so that they could get back inside the van faster. Gonzalez indicated he was not sure of who had shot the victims in the residence but did advise that both Wayne Coldiron and Leonard Gonzalez had entered the residence armed with handguns.

On 7/09/2009, Deputies responded to the scene of a Home Invasion double Homicide. Upon arrival the bodies of Byrd and Melanie Billings were located [redacted]. Two of the doors leading into the residence appeared to have been forced open and review of the video surveillance from the residence revealed three intruders entering the residence after exited in red in color Dodge van. All three suspects were armed and wearing masks, two carrying long guns, one possibly being [redacted] and the third carrying [redacted]. Spent shell casings recovered at the scene were 9mm shell casings. Further review of the video surveillance showed that just after the three subjects left the van entering the home that the van moved forward a few feet just as Gonzalez Sr. had reported. Also noted on this video one of the intruders could be seen leaving the van from the drivers side door which also would correlate to the details given by Gonzalez Sr. of him having to move over to the drivers seat in order to pull the van forward a bit. [redacted] just before the van is seen driving up to the front of the residence. This too is given in the version of events described by Gonzales Sr. who reported other subjects including his son arriving at the scene in another vehicle.
