[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07/09/2009, the bodies of Byrd and Melanie Billings was discovered dead at their residence located at 9717 Mobile Highway in Escambia County, Florida. They are victims of a homicide. During the course of this investigation a Dodge Van was captured on the surveillance video transporting the unknown suspects to the scene of the homicides.

After receiving information on the Dodge van it was located at the residence of Leonard Patrick Gonzalez Sr.'s located at 318 Palm Court. The Dodge van was parked behind a barn in the back yard of this residence. The van had

been altered by one of the rear doors having been stripped down to the metal and one of the rear doors being partially painted, also a visible primer spot above the right rear tire had been freshly painted.

On 07/12/2009, in a recorded interview the suspect Leonard Patrick Gonzalez Sr. stated he stripped the paint and painted the side of the van. S/Leonard Gonzalez Sr. also stated he did this to change the appearance due to the van being used in the homicide.
