[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07-09-09, in Escambia County Florida, Gary Lamont Sumner Jr did commit the offense of murder. The facts are as follows:

On 07-09-09, at approximately 1930 hrs, a murder occurred at 9717 Mobile Hwy, in Escambia County Florida. Two victims were shot multiple times and expired at the scene. Video surveillance at the residence captured multiple assailants entering the residence wearing dark shirts and black colored cargo/BDU type pants. They were armed with at least one handgun and two long guns, and wearing masks. Video surveillance also indicated there was a red Dodge van and a light colored SUV occupied by the assailants at the time of the incident.

Upon follow-up investigation information developed Leonard Patrick Gonzalez Sr as having been possibly involved. He was arrested on 07-12-09 on one count of accessory after the fact to murder and during a post Miranda interview S/Gonzalez picked S/Gary Lamont Sumner Jr out of a photo line-up. Gonzalez identified S/Sumner as being the driver of the light colored SUV.

Further follow-up investigation developed Wayne Coldiron as possibly being involved. On 07-12-09 he was arrested on one count of murder. On 07-13-09, at a post Miranda interview, S/Coldiron picked S/Gary Sumner Jr out of a photo line-up and identified him as being the driver of the light colored SUV at the scene of the murder.

Based on the facts stated above a warrant affidavit was prepared for judicial review charging Gary Lamont Sumner Jr with two counts of murder.
