PROBABLE CAUSE STATEMENT
 On July 14, 2009 S/Frederick Lee Thornton Jr., was arrested in Okaloosa County on an open count of Murder (2 cts) which occurred in Escambia County. Investigator Robert Grappone, of the Okaloosa County Sheriff's Office, provided a probable cause arrest report stating that S/Thornton admitted to being involved in the murder of Byrd and Melanie Billings, which occurred on July 9, 2009 in Escambia County, Florida.
