### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

CAD INCIDENT DISPOSITION CODE: [22-0] [ A ] [ 3 ] [DV]

On 10/12/09, at 5601 Scotland Circle, in Escambia County, Florida, Christian Woods did knowingly commit the act of Aggravated Child Abuse by unlawfully abandoning her two-year-old child for approximately three days.

Under case #ECSS09OFF026528, S/Christian Woods reported her daughter, Myleahya Woods, as missing and possibly abducted. At the initial point of the investigation, it was believed that all three children had been abducted and were missing. We learned of an address at 5601 Scotland Circle in which the suspect had described that she used to live there. During a check of the home, we found the victim, two-year-old Jaterius Woods, alone. The home did not have any power or running water and there was no food in the home. The home was filthy and there were several roaches

throughout the home. The victim's diaper was completely full of urine and waste and the victim had a very large bruise on his forehead. Based on our investigation, the child had been alone for approximately three days with absolutely no adult supervision. The suspect's two other children, which are twin 18-month-old black females, are still missing and an aggressive investigation is being conducted to find their whereabouts.

S/Christian Woods voluntarily responded to the Sheriff's Office for questioning. Throughout her questioning, her story changed several times and all of the locations and subjects that she described as her children being left with or at had been checked and the children have not been found.

S/Christian Woods was arrested and transported to the Escambia County Jail where she was charged with Aggravated Child Abuse. She was given a Circuit Court date of 11/05/09 and no bond per the Domestic Violence Statute.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 10/12/09, at 5606 Scotland Circle, in Escambia County, Florida, Christian Woods did knowingly commit the act of aggravated child abuse by unlawfully leaving V/Mykayhla Woods alone for approximately three days.

Under case #ESCO09OFF026528, S/Christian Woods attempted to report her daughter V/Myleahla Woods as missing and possibly abducted, and stated that her two other children, OP/Mykayhla Woods and OP/Jaterius Woods, were with her father. The investigation revealed the suspect had left all three children at the above address for approximately three days with no food, water or basic utilities. Through the investigation we did find OP/Mykayla Woods, along with her brother, OP/Jaterius Woods, at the residence and they were severely malnourished and were transported to Sacred Heart Hospital for treatment. During the same search of the residence the other daughter, V/Myleaha Woods, was found deceased in a trash can on the back porch.

On 10/12/09, at 5606 Scotland Circle in Escambia County, Fl, suspect Christian Woods did knowingly commit the act of aggravated manslaughter of a child by leaving her daughter, victim Myleahya Woods with no food, water or basic utilities which in turn caused her death.

Under the above case number, V/Myleahya Woods was reported missing and possibly abducted by her mother S/Woods. A search and investigation revealed V/Woods was deceased and was found thrown in a trash can at the suspect's residence.

S/Woods was read her Miranda rights in which she understood and confessed in a sworn recorded statement to Inv. Bobby Guy that she did leave all three of her children in her home with no supervision for approximately three days. Also
