ORDINANCE 02-11

AN ORDINANCE SETTING THE DATE, TIME AND PLACE OF THE NEXT NONPARTISAN TOWN OF CENTURY, FLORIDA ELECTION FOR THE OFFICE OF MAYOR, AND COUNCIL SEAT NO. 1, AND COUNCIL SEAT NO. 2; SETTING THE QUALIFYING DATES, VOTER REGISTRATION DATES, QUALIFICATIONS OF CANDIDATES, AND SETTING OF FEES:

BE IT ORDAINED BY THE TOWN COUNCIL:

Section 1: There will be an election held Tuesday, October 11, 2011 at Century Town Hall, 7995 North Century Blvd., Century, Florida from 7:00 a.m. to 7:00 p.m.

Section 2: The purpose of the election is to elect members to the following:

Mayor Council Seat No. 1 Council Seat No. 2

Section 3: Qualifying will be held from noon, Monday, August 1, 2011 until noon, Friday, August 5, 2011. Any registered voter living in the Town of Century may qualify at Town Hall that Monday from noon until 3:00 p.m., Wednesday from 10:00 a.m. until 1:00 p.m., or Friday from 8:00 a.m. until noon; or, at the Supervisor of Elections office at 213 Palafox Place, 2nd Floor, Pensacola, FL 32502 that Monday through Friday from 8:00 a.m. to 5:00 p.m.

Additionally, an elector may mail his or her qualifying forms to the Supervisor of Elections Office, P.O. Box 12601, Pensacola, FL 32591-2601 or bring forms to the Supervisor of Elections office at 213 Palafox Place, 2nd Floor, Pensacola, FL 32502. Mailed or hand delivered qualifying forms will be accepted early beginning Monday, July 18, 2011 until no later than noon Friday, August 5, 2011.

- **Section 4:** For the October election voter registration books will close Monday, September 12, 2011; and, for the general election voter registration books will close on Monday, October 10, 2011.
- **Section 5:** A run-off election will be held, if necessary, Tuesday, November 8, 2011 at Century Town Hall, 7995 North Century Blvd., Century, Florida from 7:00 a.m. to 7:00 p.m.
- **Section 6:** To qualify for the office of mayor, a candidate must be a registered voter in the Town of Century for six (6) months prior to the date the candidate qualifies for office per Section 4.02 of the Town of Century Charter and must pay a qualifying fee. The qualifying fee is comprised of an Election Assessment based on 1% of the annual salary equal to \$160.80 plus a \$25.00 filing fee required by the Town of Century for a total of \$185.50.

- **Section 7:** To qualify for the office of town council, a candidate must be a registered voter in the Town of Century per Section 3.02 of the Town of Century Charter, and must pay a qualifying fee. The qualifying fee is comprised of an Election Assessment based on 1% of the annual salary equal to \$33.00 plus a \$15.00 filing fee required by Century Town Council for a total of \$48.00.
- **Section 8:** This ordinance shall become effective immediately after its passage.
- **Section 9:** The Town Clerk is directed to immediately provide a copy of this executed Ordinance to the Supervisor of Elections office.
