



# Residential Painting Grant Program

# **Escambia County Community Redevelopment Agency (CRA)**

This program will provide a One-Time funding up to \$2,000 Grant for the property owner as detailed below.

### **Program Intent**

The intent of the Residential Painting Grant Program is to provide funding assistance for exterior painting improvements to the existing residential structures located within the County's designated CRA Community Redevelopment Districts (CRD).

### **Program Eligibility**

Residential Painting Grant Program grants funding for property improvements shall apply to the following:

- □ <u>Location:</u> Properties must be located within one of the following County's designated CRDs: Barrancas, Brownsville, Cantonment, Englewood, Palafox, and Warrington.
- □ Ownership: Applicant(s) must be the property owner(s) and must sign the Grant Program application and any other related documents. Applicant will be responsible for maintaining the improvements upon completion.
- <u>Application:</u> Applications are accepted on a first come, first serve basis. This is a one-time funding approval for the property. Grant funds cannot be used on properties that have judgment liens, any code violations, and delinquent taxes.
- □ <u>Design Review:</u> Grant Application must be approved for appropriateness before any improvements can begin.

# **Criteria for Project Selection:**

- > Exterior Painting only
- > Prep Work (ex. Stripping, sanding, minor wood repair/replacement, pressure washing, etc.)
- Painting Contractor will be licensed.
- > Pre-selected shades of color will be provided by the CRA.

#### **Documents Needed**

- Copy of Deed
- ➤ Copy of Homestead Exemption Card or latest Property Tax Bill
- ➤ Valid Driver's License or Photo ID
- ➤ Copy of Social Security Card for all household members
- Income Verification (letter from Social Security, VA, etc) for all household members
- Employment Verification for all household members 18 and older

### **Residential Painting Grant Program Requirements:**

**Owner Match: (based on household income)** 

#### **Household Income greater than 80% of Pensacola Area Median:**

**50 Percent:** Painting Grant Program funding may not exceed 50% of the total cost of the project or \$1,000; whichever is less. The property owner must expend one dollar into the project for every CRA dollar committed to the project.

(Example: \$2,000 total project cost = \$1,000 property owner contribution + \$1,000 CRA Grant)

#### **Household Income between 51% and 80% of Pensacola Area Median:**

**<u>25 Percent:</u>** Painting Grant Program funding may not exceed 75% of the total cost of the project or \$1,500; whichever is less. The property owner must expend one dollar into the project for every three (3) CRA dollars committed to the project.

(Example: \$2,000 total project cost = \$500 property owner contribution + \$1,500 CRA Grant)

#### ➤ Household Income below 50% of Pensacola Area Median:

<u>**O Percent:**</u> Painting Grant Program funding may not exceed 100% of the total cost of the project or \$2,000; whichever is less. No owner contribution is required for this income category; however the owner shall be responsible for maintaining the improvements upon completion.

(Example: \$5,000 total project cost = \$0 property owner contribution + \$5,000 CRA Grant)
